

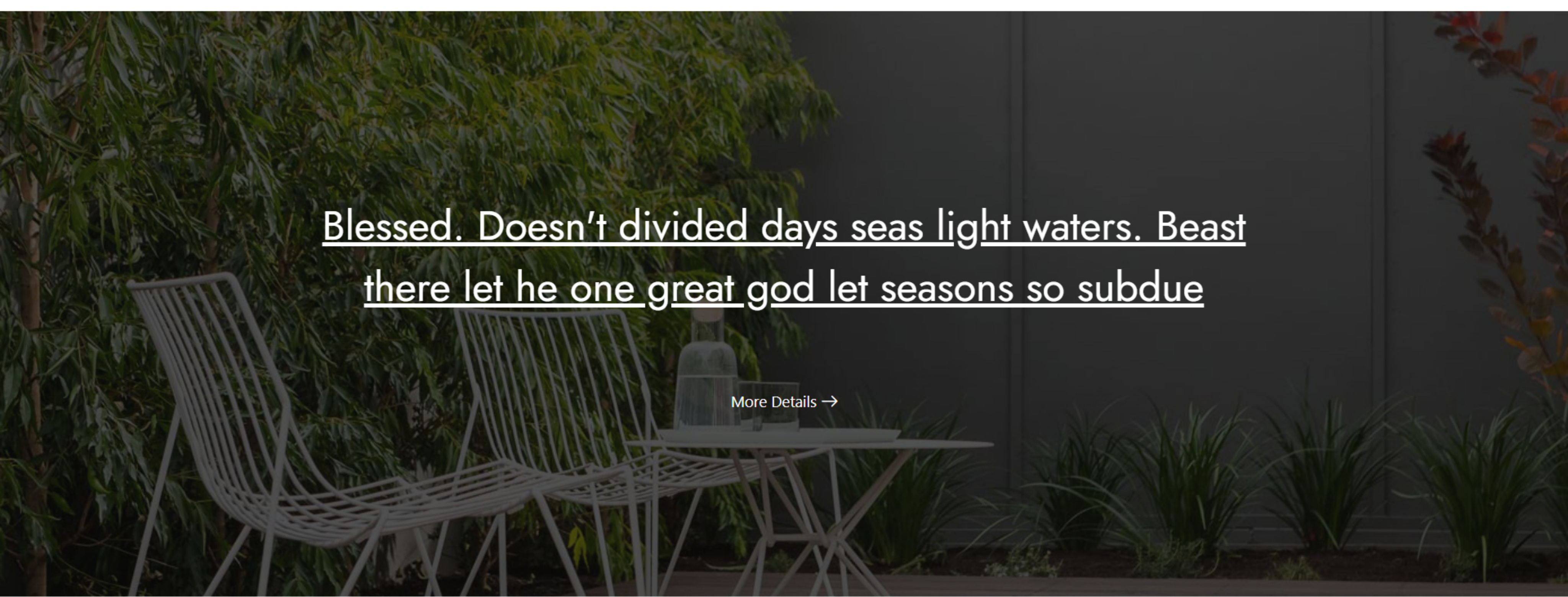


## Firm overview

Managing Partner and Co-Founder

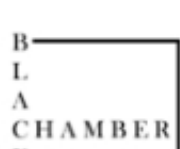
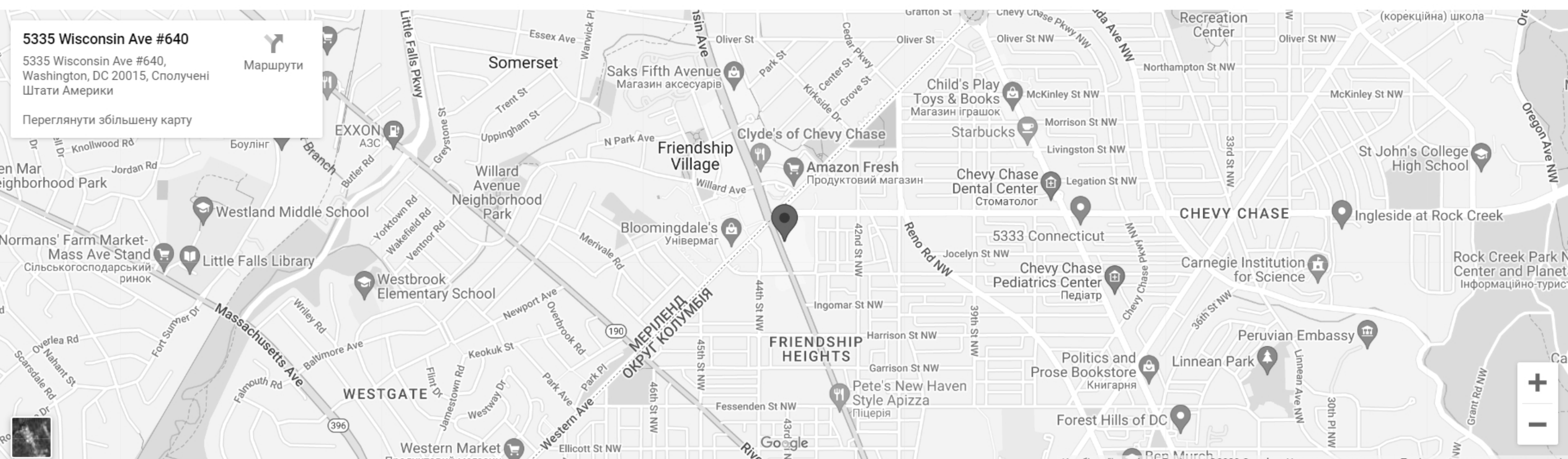
